- Chemicals that are priorities for biomonitoring in California

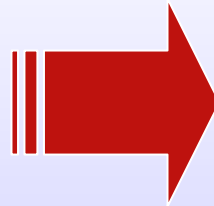
Program Elements – Priorities for SGP Peer Review and Recommendations

- Study/Sampling Design
- Results Analysis and Reporting
- Research
- Communication of Results
- Public Participation

Early SGP Guidance Needed on Chemical/Analyte Selection

Two Step Process

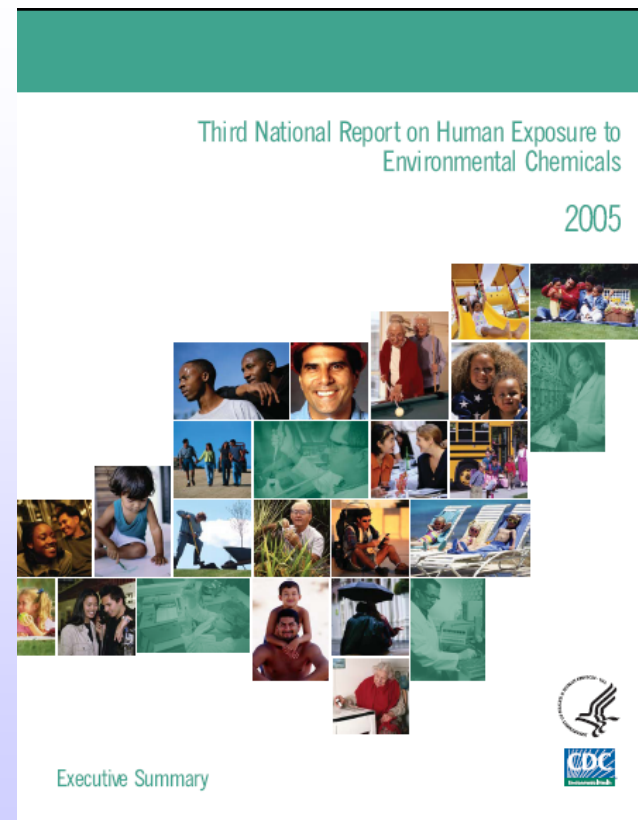
Identify

“Designated Chemicals” = CDC NHANES + SGP Additions

- CDC NHANES
 - Currently >300 chemicals
 - CDC list is evolving
- Panel Additions
 - Chemicals of interest in California
 - Criteria in statute



Chemical Priorities for Biomonitoring in California

- Criteria specified in SB 1379
- SGP plays crucial role
- Priorities expected to change over time, with program capacity and other factors
